## 2013 – 2016 ALTIMA; RUST AROUND REAR LICENSE LAMP FINISHER

APPLIED VEHICLE: 2013 – 2016 Altima (L33)

### IF YOU CONFIRM

When rust is found on the rear deck lid surface in the area surrounding the license lamp finisher (Figure 1) or replacing the license lamp finisher for any reason.

### ACTION

- Replace the license lamp finisher with the new replacement part listed in the Parts Information.
  - Refer to the Electronic Service Manual (ESM), section **EXT – Exterior** for removal and installation information.
- Repair any damaged surfaces that were in direct contact with the license lamp finisher.

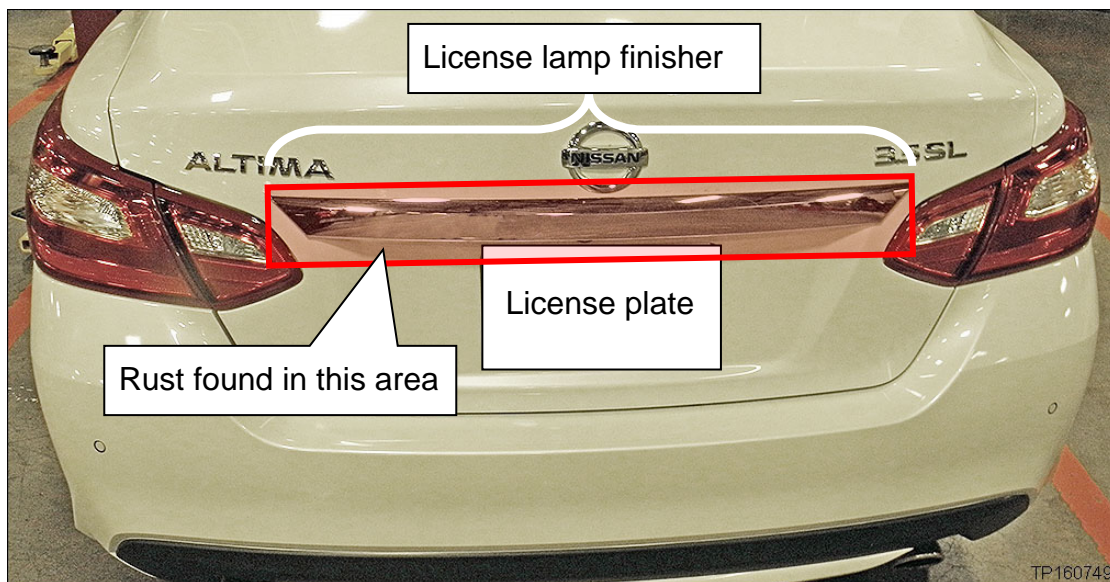
