2008-2013 ROGUE AND 2014-2015 ROGUE SELECT; RUST AROUND REAR LICENSE LAMP FINISHER

APPLIED VEHICLE: 2008-2013 Rogue (S35)

2014-2015 Rogue Select (S35)

IF YOU CONFIRM

Rust is found on the rear deck lid surface in the area surrounding the license lamp finisher (Figure 1) or when replacing the license lamp finisher for any reason.

ACTION

- Replace the license lamp finisher with the new replacement part listed the Parts Information.
 - ➤ Refer to the Electronic Service Manual (ESM), section **EXT Exterior** for removal and installation information.
- Repair any damaged surfaces that were in direct contact with the license lamp finisher.


