### **Technical Background**

The camshaft adjuster control valve may stick causing camshaft position faults.

### **Production Solution**

Measures implemented into production.



### **Service**



To avoid engine damage when working on the valvetrain, both camshafts must be locked in place according to the repair manual, see repair group 15 in Elsa.

#### Scenario 1: Valve timing incorrect

- If one or more of the above faults are stored in the engine control unit, check the valve timing according to the repair manual, see repair group 15 in Elsa.
- If the valve timing is incorrect, adjust it according to the repair manual.

#### Scenario 2: Valve timing correct

If the valve timing is correct, replace the control valve in the camshaft positioner (N205), Part Number: 03L 906
455, according to the repair manual, see repair group 15 in Elsa.



When changing the control valve, the engine should be held at TDC.

· Change the engine oil and filter.
