New Vehicles in Dealer Inventory: It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Pre-Owned Vehicles in Dealer Inventory: Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

URGENT AIRBAG SAFETY RECALL: IMMEDIATE ACTION REQUIRED!

This notice applies to a vehicle registered in your name:

We are contacting you personally because your vehicle has a recalled airbag that could **seriously injure or kill you or your passengers** if it deploys.

We have received information from Audi that the vehicle currently registered in your name with the Vehicle Identification Number [VIN] has been recalled. **If the airbag deploys, in some cases the airbag may explode** and spray sharp metal fragments or shrapnel toward you and your passengers.

According to records from Audi, your vehicle has not been repaired yet. The potentially lifesaving repair is **FREE** and parts are available now. Please **immediately call an Audi dealer** for more information or to schedule a **FREE** repair.

What should you do?

- **Immediately** contact a local Audi dealer to schedule a **FREE** repair.

- *If you think you have already taken action on this recall*, visit www.NHTSA.gov/recalls or www.airbagrecall.com and enter your vehicle's VIN to verify and ensure that no other recalls have been issued for your vehicle.



ENTER YOUR VIN

Audi is one of 19 vehicle manufacturers affected by this recall. The National Highway Traffic Safety Administration reports other auto manufacturers have 16 confirmed deaths in the United States and hundreds of alleged injuries resulting from this defect.

Please act NOW to protect yourself and your passengers. You and your family's safety on Texas roadways is our top priority.
