- 1. Clean the left front fender mounting area using 90% isopropyl alcohol and dry with clean, lint free cloth. Receiving surface MUST be clean, dry and free of any contaminants.
- 2. Warm the mounting area to 60° F (16° C).

3. Install the template with the left edge aligned with the end of the fender and the bottom level with the bottom edge of the fender. Secure the template with masking tape.

4. Firmly hold the new label and peel protective liner from the back side, being careful not to touch or contaminate the adhesive with dirt or foreign matter.
