## Subject: FCCC XC Valor Tire Pressure Monitoring System (TPMS)

Daimler Truck North America LLC (DTNA), on behalf of its wholly-owned subsidiary, Freightliner Custom Chassis Corporation (FCCC), is initiating Field Service Campaign SF644A-C to modify specific model year 2017-2022 Freightliner Custom Chassis XCM, XCP, XCR, XCS models manufactured December 15, 2015, through July 22, 2021.

On certain vehicles and under certain circumstances, the tire pressure monitoring system (TPMS) may display incorrect information such as maximum temperature and tire pressure, and/or a message that the tires are under or over-inflated.

The TPMS controller will be updated with new software, and certain units will require a longer antenna mounting bracket to extend the rear antenna downward.
