Technical Background

Certain DTCs may be entered in the vehicle due to incorrect or oversensitive self-diagnostic checks. In those cases, these DTCs are marked as "Unauthorized" in ODIS and are considered to be ghost faults.

Those DTCs do not have any impact on the operation of the vehicle and do not cause any customer complaints, even if they may appear to be related to a specific customer complaint.




Figure 2. Screenshot from ODIS with highlights.

If you see a test plan populate that has the "warning" symbol and shows the "Unauthorized DTC memory entries" message box when selecting the test plan, **please do not continue executing said test plan** (see Figure 2).
