Battery Starter Lug Failure CXU, GU

FSB 371-045, Battery Cable Lug, Failure

(May 2013)

Certain vehicles built from January 1, 2010 to May 28, 2013 with a MP7 engine may experience cracking or breaking of the 90 degree positive battery cable lug at the starter solenoid stud. In some cases, the lug is bent during assembly, and along with engine vibration may cause the terminal to weaken and fail over time. To support the cable and eliminate this failure, follow the procedure below:




Repair

- 1 Secure the vehicle for service by parking it on a flat level surface, applying the parking brake, chocking the rear wheel, and placing the transmission in neutral.
- 2 Disconnect all cables from the negative (ground) battery terminals to prevent personal injury from electrical shock and prevent damage to electrical components.
- 3 Remove the fastener from the heat shield bracket.


- 1. Screw
- 4 Preassemble the bracket and the saddle.


- 1 Bracket
- 2. Saddle
- 3. Socket Screw
- 4. Nut

5 Install the bracket onto the vehicle and secure.

- 1. Socket Screw
- 2. Saddle
- 6 Install the cable tie around the saddle and the positive battery cable going to the starter solenoid.



- 1. Cable Tie
- 2. Positive Battery Cable

Note: Battery cable may need to be loosened/retightened from back of starter solenoid in order to reach the saddle. Tighten to $26 \pm 1.5 \, \text{Nm}$ ($19.2 \pm 1.1 \, \text{ft lb}$).

7 Install all the previously removed cables to the negative (ground) battery terminals.
