#### **DESCRIPTION**

Some vehicles may experience one of the following 2 symptoms, even though the windshield is clear:

	Model	Symptom	Warning Light
1	CX-3 CX-5 Mazda6	Lane Departure Warning System (LDWS) warning light turns on at idle.  DTC C1001:92 (Poor functioning of Forward Sensing Camera (FSC)) is stored in memory.	
2	CX-5 Mazda6	Adaptive LED Headlights (ALH) warning light turns on while driving.  DTC C1001:92 (Poor functioning of Forward Sensing Camera (FSC)) is stored in memory.	-;Ф́-

Under certain driving conditions, the Forward Sensing Camera (FSC) may detect a dirty windshield (not clear). Customers having this concern should have their vehicle repaired using the following repair procedure.

  - Mazda6 FORWARD SENSING CAMERA (FSC) REMOVAL/INSTALLATION
- 3. Verify repair.
