Warranty Campaign

ISL ISX CM2350 Side Inlet SCR Replacement Emissions Campaign

Attention

This is to revise and replace Campaign 1561, dated 21-Oct-2014. This revision is to:

1. Add a part number, and
2. Modify part descriptions, and
3. Add a clarifying note.

If additional information is required, contact your Cummins Warranty Operations Group Leader.

Description

This Campaign is being issued to address conversion efficiency issues on ISX12 CM2350, ISX15 CM2350, ISL CM2350 2013 aftertreatment configurations in which the DRT is directly

connected to a Side-In SCR. The SCR **must** be replaced.

Action

In order to qualify for repair under this field action, an engine:

1. will be covered Regardless of coverage status, and
2. **must** be on the attached ESN list.

After verifying that the engine meets the above requirements, perform the following actions:

1. Replace the SCR Catalyst. Please refer to Procedure 011-036 in the Service Manual for Aftertreatment Selective Catalytic Reduction (SCR) Catalyst. Please reference Attachment B for replacement part number.
2. Vehicles that are registered in California have two additional requirements which are detailed below:
 - a. A "Label Authorized Change," Cummins part number 5297400, **must** be filled out per the attachment. Please refer to Attachment B. Clearly print or type "SCR Replacement" in the center box. Fill in the Campaign Number, Distributor or Dealer Code, and Date information. Peel off the backing material and install the label on the engine valve cover near the engine data plate. There is a clear protective cover on this label; peel the backing off of this cover and push the clear cover over the printed material. This will help protect the label during engine operation. Label cost and appropriate SRT time can be claimed per Campaign guidelines.
 - b. An "Emissions Campaign - Proof of Correction" form, Bulletin # 4310621, **must** be filled out and provided to the Customer. Inform the Customer to retain this certificate as proof that the Emissions Campaign has been performed. This form may be required as proof of an Emissions Campaign by the State of California, for vehicles registered in that state, the next time the vehicle registration is renewed. Form cost and appropriate SRT time can be claimed per the Campaign guidelines.

NOTE: Certified repair locations outside of California, who elect to perform this campaign on engines installed in vehicles which are registered in the state of California, are authorized to do so if they have the two items noted above in their inventory.

Material Disposition

Materials removed as a result of this field action **must** be scrapped.
