REVISION SUMMARY

Under BACKGROUND, a symptom was added.

BACKGROUND

American Honda has made several shift quality improvements in the 2015 and 2016 TLX V6.

SYMPTOM	UPDATE			
There is a sensation of acceleration while coasting down a hill.	Engine mapping has been changed to better manage 8-7 and 5-4 downshifts with the throttle closed.			
There is a sensation of a surge while braking.	and 5-4 downshints with the thiothe closed.			
The transmission feels like it stays in gear too long.	Transmission mapping on the 5-4-3 downshift when accelerating at low engine speeds was changed to a 5-3 downshift to provide a quicker acceleration response.			
P2638 (Does not turn on the MIL)	Improved torque accuracy monitoring.			

CORRECTIVE ACTION

Update the TCM software. Clear all DTC's created during the update and do the idle learn procedure.

This software update will change the way the transmission shifts.

After the update it may take up to 30 miles for the transmission to adapt to the client's driving habits.
