## 2011-14 Odyssey: MIL Comes On with DTC P0404

(Supersedes 13-095, dated November 18, 2013, to revise the information highlighted in yellow)

#### **REVISION SUMMARY**

Under AFFECTED VEHICLES and SOFTWARE INFORMATION, 2011-12 models were added.

#### **SYMPTOM**

The MIL comes on with DTC P0404 (EGR valve circuit range/performance problem).

#### **POSSIBLE CAUSES**

During extended driving, the PCM may command excessively high lift EGR values that may damage an internal component in the EGR valve.

#### **CORRECTIVE ACTION**

Replace the EGR valve and update the PGM-FI software.





### **REPAIR PROCEDURE**

1. Remove the engine cover.



2. Disconnect the EGR valve 5-pin connector



- 3. Remove the EGR valve.
- 4. Install the new EGR valve in the reverse order of removal and torque the nuts to 22 N-m (16 lb-ft).
- 5. Update the PGM-FI software. Refer to Service Bulletin 01-023, *Updating Control Units/Modules*. END
